



COBS Bread “Share The Goodness 54-Pack Giveaway” Contest Rules and Regulations - USA

1. CONTEST DURATION

The COBS Bread - **Share The Goodness 54-Pack Giveaway** (hereinafter, the “**Contest**”) is being held by COBS Bread, also known as BD Canada Ltd. (hereinafter, the “**Sponsor**”). The Contest starts on or around 11:00:01 a.m. Pacific Time (“**PT**”) on February 27, 2020 and ends on or about 09:00:00 p.m. PT on March 16, 2020 (the “**Contest Period**”).

2. ADMISSIBILITY

The Contest is only open to legal residents of the state of Connecticut (CT), who are nineteen (19) years of age and older at the time they enter the Contest. Employees of COBS Bread, and its parent, subsidiary, or affiliated companies, their advertising and promotion agencies, or their other representatives or agents, and their immediate family members and anyone with whom they are living with, are not eligible to enter or win the contest. “Immediate family” means parents, siblings, children, spouses. Participants must have valid identification and/or documentation in order to be eligible to win the prize. To be admissible, entries must be received within the Contest Period and all eligible entries will be entered into a random draw. The contest is subject to all applicable federal, provincial and municipal laws and regulations.

3. PARTICIPATION - HOW TO ENTER THE CONTEST

No purchase necessary. Entries may be made:

- a. **In-Bakery:** by fully completing COBS Bread entry form available in a participating bakery and placing it in the draw box.
- b. **Via Regular Mail:** Participants may enter by printing their full legal name, city or town of residence, telephone number and email address and a 25-word or more description of why they love about COBS Bread hot cross buns (not mechanically reproduced). Entries must be mailed in a self-addressed envelope to: COBS Bread #210-1100 Melville Street, Vancouver, BC. Canada V6A 4A6. A valid email address must be provided. Limit of one (1) entry per person. Entries must be received by COBS Bread prior to the end of the Contest Period and will be added to the contest entries of COBS Bread High Ridge and have the same odds of winning as the odds for that bakery. COBS Bread is not responsible for lost mail. Receiving COBS Bread’s e-newsletter does not improve the odds to win a prize in the contest.

One entry per transaction. Only one entry per person per bakery visit. Only fully completed entries will be accepted and eligible for entry into the contest. Entries that are fraudulent are not permitted and will be declared invalid. Paper entries that are illegible, altered, mutilated or tampered with will be declared invalid. All entries become the property of COBS Bread and will not be acknowledged or returned.

4. THE PRIZE

- A fifty-four (54) Pack of Assorted Flavored Hot Cross Buns (the “Grand Prize”) is available to be won; with one (1) prize being given away at each participating bakery.
- Each Grand Prize will consist of 54 Hot Cross Buns (approximate retail value \$70).
- The flavors will be based on availability at the participating bakery.
- Limit one Grand Prize per household. Odds of winning a Grand Prize will depend on the number of entrants at each bakery.
- Prizes are non-transferable, cannot be substituted, may not be sold, combined with any other offer or redeemed for cash. Sponsor reserves the right to substitute the Grand Prize or a portion of the Grand Prize for a prize of equal value for whatever reason.

5. PRIZE DRAW AND CLAIMING

- The Contest will run Thursday, February 27, 2020 till close of business Monday, March 16, 2020. The Contest winner will be drawn randomly from eligible entries to be held on Sunday, April 05, 2020 at each participating COBS Bread bakery location. Odds of winning depend on the number of entries received at each COBS Bread bakery location.
- Following the random draw, the selected entrant will be contacted by telephone number provided in the entrant’s Contest entry form.
- In order to be declared a winner, the selected entrant must:
 - be reached by phone within seven (7) days following the random draw
 - correctly answer, unaided, a time-limited, mathematical skill-testing question; and
 - sign a declaration within five (5) days of its receipt thereof from the Sponsor stating that he/she:
 - has read, understands and complies with the Contest Rules;
 - releases and discharges COBS Bread, the Contest organizers and their respective parents, subsidiaries and affiliates; and
 - consents to the announcement of the winner's name and the use by or on behalf of COBS Bread of the winner's name, city location, photograph, likeness, voice or statements for advertising and promotional purposes without any further compensation to the winner.
- Should the selected entrant fail to comply with any of the requirements set out in Section 2 and 3, the prize will be automatically forfeited and another entrant will be selected by random draw.
- Unclaimed and uncollected prizes after 3 days will no longer be available. Selection of alternate eligible Entries is at the complete discretion of the Sponsor and all prizes may not be awarded should an entrant or entrants be unable to be contacted in accordance with these rules or are otherwise unwilling or unable to comply in full with these Rules. Due to the expiry date of the prizes, COBS Bread has the right not to redraw new winners should a winner not be declared for a particular prize within the timeframe designated by the Sponsor.

- The prize is to be awarded and picked up at each bakery. The winner must show proper photo ID (i.e. Driver’s license) for pick up.
- The winner is to make arrangements to pick-up their prize within five days (5) of notification.
- COBS Bread reserves the right, in its sole discretion, to substitute the prize or any portion thereof for another prize of equal or greater value, or its monetary equivalent.
- Entrants (i) acknowledge compliance with these Official Rules including all eligibility requirements and, (ii) agree to be bound by the decisions of the Sponsor and contest administrator, made in their sole discretion, which shall be final and binding in all matters relating to the Contest. Entrants who have not complied with these Official Rules are subject to disqualification.
- Entrants and/or winners assume liability for injuries caused, or claimed to be caused by participating in the Contest, or by the acceptance, possession, or use of any prize awarded, including but not limited to claims/damages for personal injury, or property damage.

6. ADVERTISING

In order to be declared a winner, the selected participants must both authorize COBS Bread, and its representatives, to use his/her first and last name, city and province of residence, photograph, image, video, voice, and comments for advertising purposes in any and all media, without any additional compensation, remuneration or reparation whatsoever.

7. GENERAL CONDITIONS

All Entries received will become the property of COBS Bread and will not be returned. Proof of submitting an Entry will not be deemed proof of receipt.

By entering the Contest participants agree to be bound by these Rules and any subsequent amendment(s) made by COBS Bread, and agree to be bound by the decisions of COBS Bread, which shall be considered final, binding and irrevocable in all aspects relating to the Contest.
